The H1-B Facts divides H1-B Facts Queues into Congressional Districts, by state, by city and by employer. The queries reside all over the different states, Californians has a multiples of PDF queries. One also find out how many H1Bs are in a single building, by company name, and by city name. Geo data is information about geographic locations that is stored in a format that can be used with a geographic information system, H1-B Facts uses latitude and longitude to sort other H1B data elements such as addresses into groupings based on the location determined by the latitude and longitude. This is a powerful feature that distinguishes H1B Facts from other H-1B database applications.

Viewing and researching H-1B data by congressional district is a good launching point from which to examine the impact of H-1B employees within a congressional district workplace. It allows data analysts to get a feel for which area of a given state has the distribution of H-1B employees and determine it's impact. Worksite Latitude Longitude which when sorted ascending points to a group by an address, then one can examine all the H-1Bs working at that address in that neighborhood or surrounding geographical location.

Aggregate SQL functions are used with the GROUP BY clause of the SELECT statement.

H1B Fact Data Definition: An "H-1B Dependent Employer" is a U.S. employer that hires a higher amount of H-1B employees than the normal standard.

It is a misnomer for one would think that a one-to-one relationships would exist for an individual H1B Visa holder and the total worker number; thus "total visas" and "total workers" should be the same number.

They do not for the employers work several individual H-1Bs for a H1B visa application; thus one visa may be used for multiple workers; thus the difference between the two total on the H1B Facts report.

It is the total workers that are used to determine the actual number of H-1B's that reside in the various office work site locations.

A more governmental write up is as follows:

The H1B visa shall maintain a one to one relationship as a subject person. The visa shall be treated as a passport, the identity of the person in form of a picture and visa immigration number.

Current LCA visas have a potential of one-to-many set of visas that are interchangeable as employers work several individual H-1Bs for a H1B visa application; thus one visa may be used for multiple workers. The system shall eliminate this practice; a strict-one to one H1B Visa shall be created, maintained and not changed.

Employment changes such as new employment, continuation of previously approved employment, change in previously approved employment, new concurrent employment without change with the same employer, change in employer and amended petition shall be instituted for that visa person and that visa only. For every H1B visa there one worker and one work site address location with latitude and longitude coordinates.

A singular visa will eliminate fraud and abuse of the multi-interchangeable LCA visas, The total number of visas shall equal the total number of workers on LCA reports, It is the total workers and a one-to-one visa relationship to determine the actual number of H1Bs that reside in the worksite location.

Important Note: This public disclosure file contains administrative data from employers' Labor Condition Applications (ETA Forms 9035 & 9035E) and the certification determinations processed by the Department's Office of Foreign Labor Certification, Employment and Training Administration where the date of the determination was issued on or after October 1, 2017, and on or before September 30,



2018. All data were extracted from the Office of Foreign Labor Certification's iCERT Visa Portal System; an electronic filing and application processing system of employer requests for H-1B nonimmigrant workers.

Additional data was obtained by filing various FOIA (Freedom of Information Act) requests and using data obtained from those and other FOIA requests are from the US Department of Labor. The key data obtained is labeled Worksite Address, a set of data elements that identify the physical location in and or for latitude and longitude pin points.

After compiling and merging the above mentioned data, latitude, longitude, and congressional district data was approximated by geocoding the worksite and employer addresses provided by the US Department of Labor.

One must assume a very widespread population of H-1B workers is not spread out through out the entire state of Connecticut. Most likely H-1B population is in the mid sized cites like Bridgeport. New Haven. Hartford. Stamford. Waterbury. Norwalk. NS Danbury.

Wage Levels indicate that the vast majority are entry level or qualified, depriving STEM grads and junior level programmers of job opportunities, clearly evident. If you are a STEM grad in computers, your chances are ZERO for job placement. Fully competent H1-Bs in Connecticut is strikingly low in view that Connecticut is an insurance state, but only represents 4.49% of total.

H1-B Labor is not cheap in H-1B Connecticut, if the entry level median salary is \$67,496.00 with the median is defined as half of the population is less and half the population is greater, thus many



many salaries are below the median \$67,800.00. The median for qualified is \$80,267.00, a high number. One wonders are people can survive in an expensive location like Connecticut. It is H-1B bunk bed time the shitty apartments that abound.

"Bridgeport, Connecticut, had the highest average salary (\$100,200) of any metro area,".

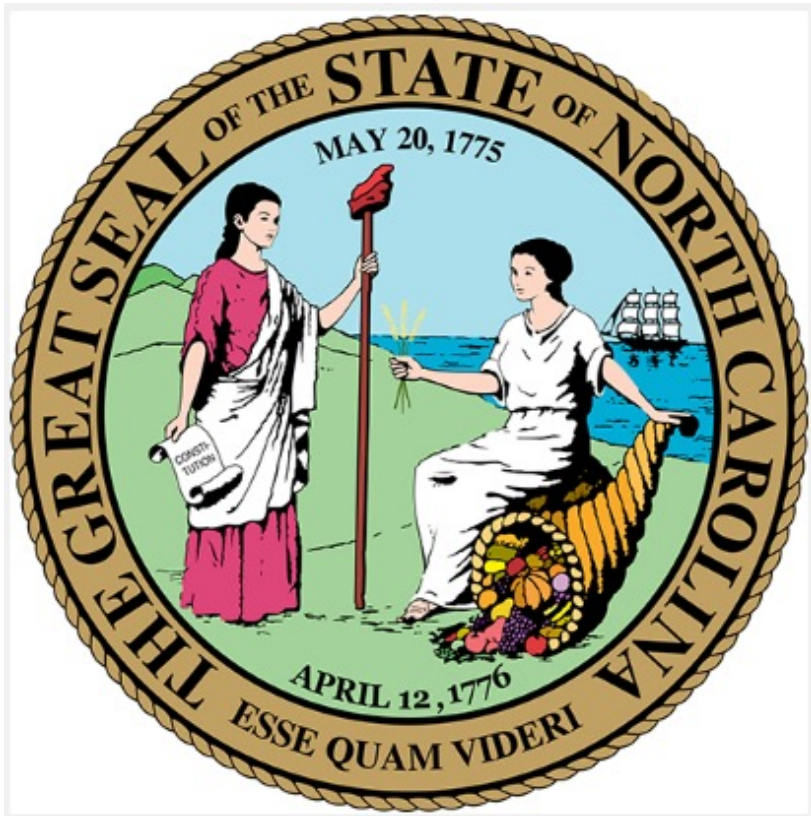
